Hence, the petitioner is permitted to submit a copy of the proposal to the 2nd respondent, which is said to be filed on 25.02.2018, within a period of two weeks from the date of receipt of a copy of this order and the 2nd respondent, in turn, is hereby directed to consider the same on merits and in accordance with law and pass necessary orders, after affording due opportunity of hearing to the petitioner, within a period of six weeks therefrom.

6. With the above direction, the writ petition is disposed of. No costs.
