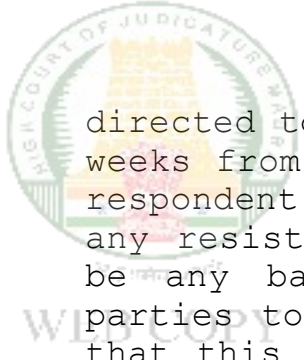

directed to conclude the survey exercise within a period of twelve weeks from the date of receipt of a copy of this order. The third respondent shall issue notice to all the adjacent land owners. If any resistance or opposition is encountered and there appears to be any basis for the same, the authority shall relegate the parties to move the jurisdictional civil Court. It is made clear that this Court has not pronounced anything on the merits of the matter.

3. The Writ petition stands disposed of, accordingly. No costs.
