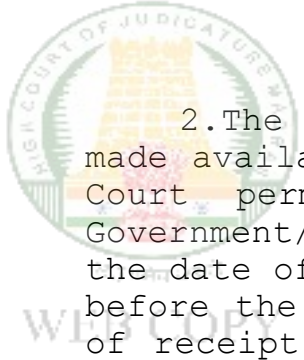

3.The writ petition is dismissed with this liberty. The Registry is directed to return the original copy of the award to the petitioner's counsel. No costs. Consequently, connected miscellaneous petition is closed.
