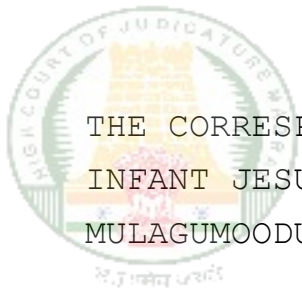

**COMMON ORDER**

When the matters were taken up for hearing, the learned counsel for the petitioners pointed out that the impugned G.O. has already been quashed vide order dated 30.01.2019 in W.P.(MD)Nos.23789 of 2018 and etc. batch by the Principal Seat of this Court. This Court went through the said order and it is seen that the order impugned in the G.O. was actually quashed in the said writ proceedings. This Court wanted to know as to why, the petitioners filed these writ petition. The learned counsel appearing for the petitioners replied that the authorities are taking a stand that since the petitioners herein are not parties to these writ proceedings, they will have to get an individual order in their favour. I fail to appreciate the stand of the respondents. This Court in order to address the grievance projected by the writ petitioners, makes it clear that the G.O. impugned in these writ petitions has already been quashed by the Principal Seat of this Court in the writ proceedings referred to earlier and that the petitioners herein can avail the benefit of quashing of the G.O.

2.The writ petitions are disposed of accordingly. No costs. Consequently, connected miscellaneous petitions are closed.

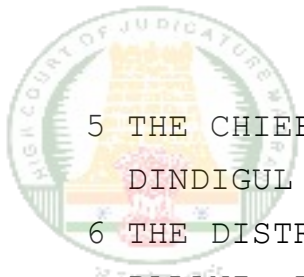

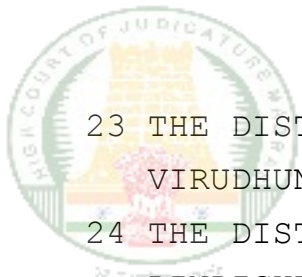
