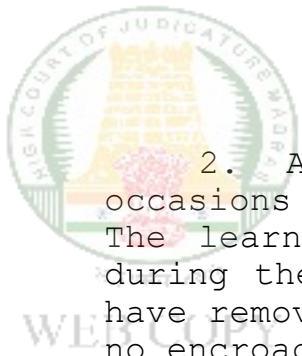

The Writ Petition is filed seeking for a Writ of Mandamus to direct the Respondent no.2 to remove the illegal encroachments put up by the 3rd and 4th respondents in the Public Pathway and Poramboke land on the basis of the petitioner's representation dated 16.10.2018.
