PRAYER: Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorarified Mandamus, to call for the records relating to impugned order of the second respondent in Na.Ka.C5/18880/2013 dated 29.11.2013 quash the same and consequently direct the respondents herein to mutate the revenue records in respect of survey No.93/3 measuring 2.50 acres situated in Ayyaruli Thatchan Village, Paruthikanmoi Group, Kalayarkovil Taluk, Sivagangai District, as per the decree dated 30.09.2013 made in OS.No.56 of 2013 on the file of the District Munsif Court, Sivagangai, within a reasonable time as may be fixed by this Court.

ORDER

The writ petitioner questions the impugned proceedings issued by the second respondent District Revenue Officer, Sivagangai. The petitioner's contention is that the impugned proceedings are running counter to the Judgement and Decree dated 30.09.2013 made in O.S.No.56 of 2013 on the file of the District Munsif Court, Sivagangai. In this regard, the petitioner has given petition dated 21.12.2018 and that the second respondent appears to have taken up the matter for enquiry.

3.Accordingly, this writ petition is disposed of. The petitioner's rights are left open. The second respondent shall pass orders after hearing all the parties and by taking note of all the materials on record including the judgment and decree dated 30.09.2013 referred to above. No costs. Consequently, connected miscellaneous petitions are closed.
