3.The learned counsel for the petitioner submitted that the petitioner seeks protection from certain local residents for erecting cell phone tower in a private land, which he obtains for lease for the said purpose.



4.The learned Government Advocate (Crl.Side) concurred with the said statement and submitted that if requires necessary protection would be given. She also submitted that the representation / complaint preferred by the petitioner is pending with the respondent police.

5.In view of the above, the respondent police is now directed to cause such necessary enquiry on the complaint of the petitioner and take such appropriate decision as may be necessary to secure the rights, if any, of the petitioner.
