Prayer: This Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of of Mandamus, directing the respondents to pay the compensation to the petitioner for the land measuring in survey number 314/7 and 314/5 with an extent of 1914 sq.ft of House site bearing Plot NO.5 in Annai Sivakami Nagar in Perungudi Village, Madurai District on the basis of the petitioner representation dated 01.04.2019.

5.Be that as it may, now the award is ready in the office of the respondents. It is for the petitioner to get the same and if at all he has got any grievance with regard to the quantum of award, the petitioner can workout his remedy in the manner known to law.
