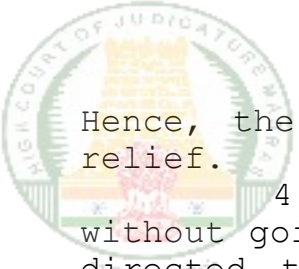

ORDER

This Writ Petition has been filed seeking a direction to the respondents to grant permission and necessary police protection to perform the cultural programme (ie.,) Karagattam on 07.06.2019 at 09.00 p.m., to 03.00 a.m., and Adal Padal on 08.06.2019 and 09.06.2019 at 07.00 p.m., to 11.00 p.m., in the festival of Arulmighu Sri Selva Maha Mariamman Thirukovil at Keelkalnayakkan Street, Uraiyur, Trichy District.

2. Heard both sides.

3. The grievance of the petitioner is that seeking permission and protection to perform the cultural Programme (ie.,) Karagattam on 07.06.2019 and Adal Padal on 08.06.2019 and 09.06.2019 in connection with the festival of the above said temple, the petitioner made a representation on 28.05.2019 to the second respondent and the said representation was not considered so far.



Hence, the present Writ Petition has been filed for the aforesaid relief.

4. Considering the facts and circumstances of the case, without going into the merits of the case, the second respondent is directed to consider the representation of the petitioner dated 28.05.2019 and pass suitable orders on merits and in accordance with law, forthwith.

5. The Writ Petition stands disposed of with the above direction. No costs.
