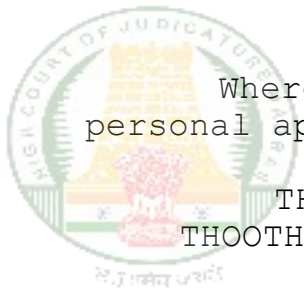
Prayer in WP(MD).No.12981 of 2019 :
