This Writ Petition has been filed seeking a direction to the respondents to grant permission to perform the program of 'Adal Padal' on 14.06.2019 night at about 06.00 p.m., to 11.00 p.m., at Sri Periyakandiamman Temple festival Nagainallur, Nagainallur-Post, Thottiyam Taluk, Trichy District and to provide adequate police protection based on the petitioner's representation dated 07.06.2019.

2. Heard both sides.

The grievance of the petitioner is that seeking permission and police protection to conduct the Adal Padal programme on 14.06.2019 in connection with the festival of the above said temple, the petitioner has given a representation on 07.06.2019 to the second respondent and the said representation was not considered so far. Hence, the present Writ Petition has been filed for the aforesaid relief.



4. Considering the facts and circumstances of the case, without going into the merits of the case, the second respondent is directed to consider the representation of the petitioner dated 07.06.2019 and pass suitable orders on merits and in accordance with law, forthwith.

5. The Writ Petition stands disposed of with the above direction. No costs.
