This Writ Petition has been filed seeking a direction to the respondents to give permission to conduct the cultural programme of Adal Padal Dance (Kalai Nigaltchi) on 11.06.2019 at night about 07.00 p.m., to 12.00 p.m., in connection with the "Thiruvilla" in Arulmighu Sri Kaliyamman Thiru Kovil at Manikattiyur, Thopampatti, Aalipatti Post, Manaparai, Trichy District, based on the petitioner's representation dated 07.06.2019.

The grievance of the petitioner is that seeking permission and police protection to conduct the cultural programme, namely Adal Padal Dance (Kalai Nigaltchi) on 11.06.2019 in connection with "Thiruvilla" of the above said temple, the petitioner has given a representation on 07.06.2019 to the second respondent and the said representation was not considered so far. Hence, the present Writ Petition has been filed for the aforesaid relief.

4. Considering the facts and circumstances of the case, without going into the merits of the case, the second respondent is directed to consider the representation of the petitioner dated 07.06.2019 and pass suitable orders on merits and in accordance with law, forthwith.

5. The Writ Petition stands disposed of with the above direction. No costs.
