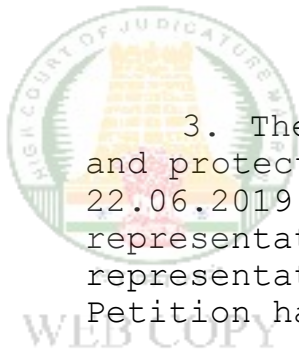

This Writ Petition has been filed seeking a direction to the second respondent to grant permission and protection to conduct Dance Programme (Adal Padal) on 21.06.2019 and 22.06.2019 in connection with the festival of Sri Aathisakthi Vinayagar Temple situated at Pillaiyarkovil Street, Pookollai, Peravurani Taluk, Thanjavur District, in pursuant to the representation dated 09.06.2019.
