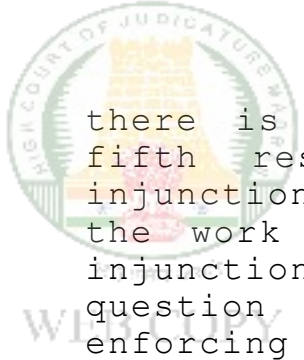
PRAYER: Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, directing the respondents to take necessary action for providing police protection for the construction of the Sri Veerapandi Ayyanar Temple situated at Ayyampatti Village, Salaigramam Post, Ilayangudi Taluk, Sivagangai District besides directing them to conduct enquiry relating to the redemption of Kalasam under the custody of fifth respondent in the light of the communication of the second respondent dated 18.02.2019 based on the petitioner's representation dated 04.02.2019 within a time frame as fixed by this Court.

ORDER

The petitioner wants grant of police protection for constructing the petition mentioned temple. The petitioner apprehends trouble at the hands of the fifth respondent. When



there is a private dispute between the petitioner and the fifth respondent, it is for the petitioner to obtain injunction against the fifth respondent from interfering with the work of carrying on temple construction. If such an injunction order is granted by the civil Court, then the question of granting police protection will arise for enforcing such an injunction order. At this stage, the question of granting police protection in favour of the petitioner as against the fifth respondent does not arise.

2. Leaving open the petitioner's right, the Writ Petition is dismissed. No costs.
