ORDER

3. The learned Additional Government Pleader appearing for the respondents submitted that the representation of the petitioner is not considered on merits within a specified time that may be fixed by this Court.

Having regard to the limited scope of the prayer, that is now sought before this Court by the learned counsel appearing for the petitioner, this Court, without expressing any opinion on the merits of the petitioner's case, directs the 1st respondent to consider the representation of the petitioner, dated 26.04.2019 on merits and in accordance with law, and pass appropriate orders, within a period of twelve weeks from the date of receipt of a copy of this order, after affording due opportunity of hearing to the petitioner.

5. With the above direction, this writ petition is disposed of. No costs.
