This Writ Petition has been filed seeking a direction to the respondents to grant permission to perform the program of 'Adal Padal' on 30.06.2019 night at about 08.00 p.m., to 12.00 a.m., at Sri Periyakandiamman Temple Festival, Pidaramangalam Post, Thottiyam Taluk, Trichy District and to provide adequate police protection, based on the petitioner's representation dated 18.06.2019.

3. The grievance of the petitioner is that seeking permission and police protection to conduct the program of 'Adalpadal' on 30.06.2019 in connection with the Festival of the above said temple, the petitioner has given a representation on 18.06.2019 to



the second respondent and the said representation was not considered so far. Hence, the present Writ Petition has been filed for the aforesaid relief.

4. Considering the facts and circumstances of the case, without going into the merits of the case, the second respondent is directed to consider the representation of the petitioner dated 18.06.2019 and pass suitable orders on merits and in accordance with law, forthwith.

5. The Writ Petition stands disposed of with the above direction. No costs.
