The petitioner also claims that he has to be paid his salaries. He is also demanding compensation. Therefore, he sought the intervention of the second respondent for sustaining his claim against his erstwhile employer. It is not in dispute that the petitioner's claim was against the second respondent.

3.Therefore, the respondents are directed to conclude the entire proceedings within a period of four months from the date of receipt of a copy of this order. This writ petition is disposed of accordingly. No costs.
