PRAYER : Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, to direct respondents No.1 to 3 to sanction and disburse education loan a sum of Rs.7,48,000/- (Seven Lakhs and Forty Eight Thousand Rupees) to the petitioner's daughter namely, G.Selsiya for pursuing her course in Doctor of Medicine M.D (Equivalent to MBBS in India) at the International Medical Faculty, Osh State University, Kyrgyzstan, Russia based on the application dated 22.10.2018 within a stipulated time.
