ORDER : The Court Made the following order :-

The petitioners apprehend arrest at the hands of the respondent police for the offences punishable under Section 498(A), 506(ii) 294 (b) 324 of I.P.C. and Section 4 of Dowry Prohibition Act and Section 4 of Tamil Nadu Prevention of Harassment of Women Act, in Crime No.Not known of 2018, seek anticipatory bail.
