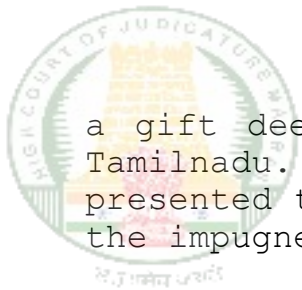

2.The writ petitioner seeks approval for a lay out. One of the formalities for getting approval is that the petitioner must execute



a gift deed conveying the pathway in favour of the Government of Tamilnadu. The petitioner prepared a gift deed dated 29.06.2018 and presented the same for registration before the first respondent. By the impugned memo dated 29.06.2018, the same was returned.

3.As rightly pointed out by the learned counsel for the petitioner, the registration of the petition mentioned gift deed is a condition precedent for getting lay out approval. Therefore, the same cannot be returned by claiming that since there is no lay out there cannot be any registration of document in question. The respondent is literally arguing in circles.

4.In this view of the matter, the order impugned in this writ petition is quashed. The petitioner is permitted to resubmit the petition mentioned gift deed and the first respondent shall receive and register the same, ofcourse, subject to fulfilment of all other formalities.

5.Accordingly, this writ petition is allowed. No costs. Consequently, connected miscellaneous petition is closed.
