ORDER

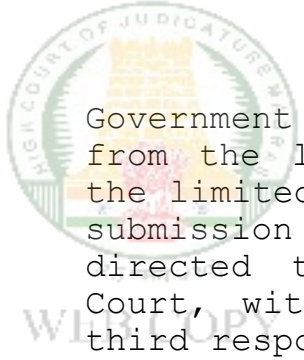

2.The prayer in the writ petition is to issue a writ of Mandamus directing the respondents to implement the direction given by the first respondent in his proceedings, dated 17.09.2018 within a time frame.

3.The grievance of the petitioner is that so many persons have encroached on the public road and the representation to remove the encroachments was not considered by the respondents.
