4.In view of the above, the respondent concerned is directed to consider the representation of the petitioner, dated 26.02.2019 and pass orders on merits and in accordance with law, within a period of two weeks from the date of receipt of a copy of this order.

5.This writ petition is disposed of accordingly. No costs.
