**ORDER**

2.The petitioner wants the election to the post of non hereditary trustee to the petition mentioned temple to be concluded. It is seen that this was subject matter in W.P.(MD)No.22875 of 2017. This Court had appointed Mr.K.K.Senthil as the Advocate Commissioner for preparing voters list. The learned Advocate Commissioner is present in person before this Court and he informs that he will be able to finalise voters list within a period of two weeks from today. Thereafter the second respondent will have to conduct election. Since the Parliament Elections are intervening, I am of the view that the second respondent can be mandated to conclude the election on or before 10.05.2019.

3.The Writ Petition is disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
