3. The Writ petition stands closed, accordingly. No costs. Consequently, connected Miscellaneous petition is closed.

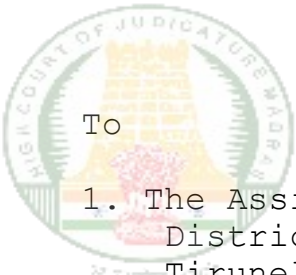
