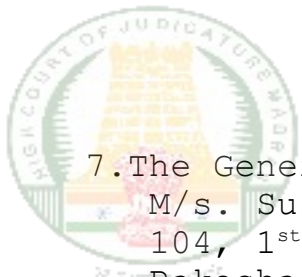

2.The learned Senior counsel appearing for the seventh respondent states that they have not erected any pole.

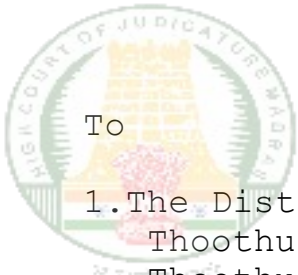
3.In view of the submission made by the learned Government Advocate and the seventh respondent, I am of the view that no further orders are necessary.
