PRAYER: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing respondents 1 to 3 to measure and demarcate the land, with reference to the field measurement book and as per the schedule found in the document in respect of Survey No.517/6, 487/3A, 487/1E an extent of 0.05.00(12 cents), 0.04.00(10 cents) and 0.02.50(5 cents), petitioner's ancestral properties in survey No.517/10 to an extent of 0.25.50 Ares out of which 0.2.83(7 cents) situated in Seeliampatti Revenue Village, Theni Taluk, Theni District, based on his online application dated 29.03.2019 and subsequent application dated 11.04.2019 within a time frame that may be stipulated by this Court.

The first respondent shall issue notice to all the adjacent land owners. If any resistance or opposition are encountered and



there appears to be any basis for the same, the authority shall relegate the parties to move the jurisdictional civil Court. It is made clear that this Court has not pronounced anything on the merits of the matter.

3. The Writ petition stands disposed of, accordingly. No costs.
