PRAYER: Writ Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of Mandamus directing the respondents to grant 5th review benefits and to effect pay revision and pension and pay arrears and pension arrears in terms of 12(3) Settlement dated 13.04.2015 and in the light of the G.O.Ms.No.61, Transport Department dated 30.04.2015 and consequently to direct the respondents to pay the difference amount of petitioner's retirement benefits.

ORDER

This writ petition is filed seeking to direct the respondents to grant 5th review benefits and to effect pay revision and pension and pay arrears and pension arrears in terms of 12(3) Settlement dated 13.04.2015 and also in the light of G.O.Ms.No.61, Transport Department dated 30.04.2015 and consequently to direct the respondents to pay the difference amount of the petitioner's retirement benefits.

5. With the above direction, the writ petition is disposed of. No costs.
