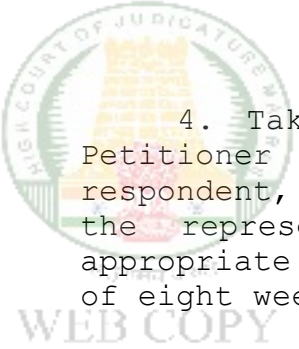

ORDER
