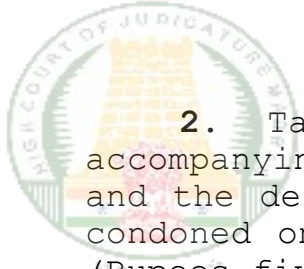
PRAYER IN WA(MD) No.SR29616 of 2017:
