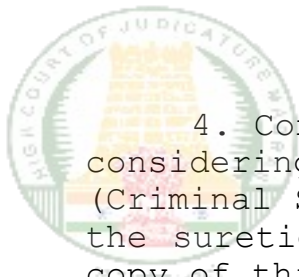

Order : This petition coming on for orders upon perusing the petition filed in support thereof and upon hearing the arguments of Mr.K.PRABHU, Advocate for the petitioner and of Mrs.M.ANANTHA DEVI Govt. Advocate ( Crl. Side) on behalf of the Respondent, the court made the following order:-

The petition has been filed to extend the time granted by this court in CRL OP(MD) No.22863 of 2018, dated 27/02/2019, for producing the sureties and for executing the bail bond.

The learned counsel appearing for the petitioner would submit that the petitioner joined in a new job at Bangalore and due to some administrative reasons, the company has not granted leave to the petitioner, therefore, he could not comply the condition and hence he could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.

3.Heard the learned Government Advocate(Criminal Side) appearing for the State.

Considering the facts and circumstances of the case and also considering the submission made by the learned Government Advocate (Criminal Side), this petition is ordered and the time for executing the sureties is extended by one week from the date of receipt of a copy of this order as a last chance.
