Prayer in CRL OP(MD).No.3136 of 2019 :

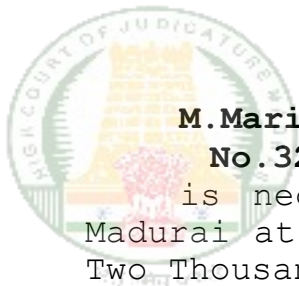
