**ORDER**

However, the petitioner is permitted to submit a fresh representation narrating all the facts and circumstances to the respondents within a period of two weeks from the date of receipt of a copy of this order. On such filing, the same shall be considered and appropriate orders be passed thereon by the respondents, on merits and in accordance with law, within a period of eight weeks thereafter.

3. The writ petition is disposed of accordingly. No costs. Consequently, WMP (MD) Nos. 9204/2016 & 9564/2017 are closed.
