be disposed of and seeks further six months time for disposal of the said case.

Accordingly, six months time is granted to the learned District Munsif cum Judicial Magistrate, Rameshwaram is directed to complete the proceedings in C.C.No.69 of 2017, within a period of six months from the date of receipt of a copy of this order.
