Thereafter, on the basis of the request made by the Trial Court on 24.09.2020, five months time has been extended.

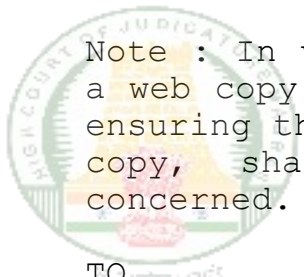
