of the Respondent Police

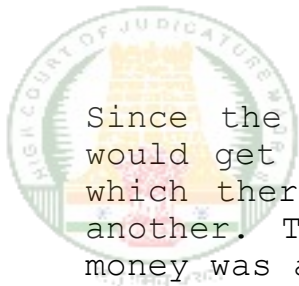
ORDER : The Court made the following order :-

2. The petitioner apprehending arrest at the hands of the
respondent police for the offences punishable under Sections 294(b),
468, 420 and 506(1) of I.P.C., in Crime No.256 of 2019, on the file
of the respondent police, seeks anticipatory bail.

3. The case of the prosecution is that the defacto complainant
had parted with a sum of Rs.4,17,000/- to the petitioner herein.

This is a case in which there has been a transfer of funds from one bank account to another. The petitioner however comes up with a version that the money was actually given to one Elangovan.
