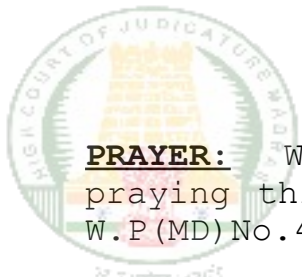

PRAYER: Writ Appeal filed under Clause 15 of the Letters Patent praying this Court to set aside the order passed by this Court in W.P(MD)No.4080 of 2019, dated 15.3.2019.

Prayer in WP(MD). 4080/ 2019 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus directing the respondents 1 to 3 to consider the requisition of the petitioner and 196 members of Kalkulam Vilavancode Taluk Co-operative, Marketing Society Ltd. Y-285, Marthandam, Kanyakumari District (KVTCMS) dated 10.12.2018 within a time frame that may be stipulated by this Honble Court and consequently direct the 1st respondent to convene a Special General Body Meeting of the Board of KVTCMS with the single agenda of removing the 5th respondent from the primary membership of KVTCMS under the presidenship of either the first respondent or any officer authorised by him in accordance with Rule 61(4) of the Tamil Nadu Cooperative Societies Rules, 1988.
