PRAYER : Writ petition filed under Article 226 of the Constitution of India for issuance of writ of certiorarified mandamus to call for the records pertaining to the selection list of Helper (Trainee) by Direct Recruitment 2013-2014 in the Electricity Department published on 20.02.2014 in their official website and quash the same in respect of selected candidates in Sl. No.301, 353, 375 and 428 totally four candidates who are having less marks than the petitioner consequently direct the respondents to include the petitioner's name in the selected list for the post of Helper (Trainee) based on his Application No.06105 dated 11.11.2013.

O R D E R

When the matter was taken up for hearing, the learned counsel for the respondents submitted that the process of selection for appointment to the post of Helper (Trainee) had been concluded by the respondents in the year 2014 and the selected candidates were appointed and they are working as Helpers (Trainees) for the past more than five years.



2. The learned counsel appearing for the writ petitioner submitted that the process of selection for appointment to the post of Helper (Trainee) was not conducted transparently and the established principles for selection were not scrupulously followed by the respondents.

3. This Court cannot adjudicate these broad grounds at this length of time, in view of the fact that the selected candidates were appointed during the year 2014 and they are working as Helpers (Trainees) for the past more than five years. This apart, the writ petitioner has not neither impleaded the appointed candidates as party respondents nor challenged the appointment orders issued in their favour in the present writ petition.

4. Accordingly, the writ petition stands dismissed. No costs. Consequently, connected miscellaneous petitions are closed.
