As the petitioner had scored less marks than the provisionally selected candidates, he was not considered for selection to the post of Junior Training Officer in the trade of Foundryman under NTC/NAC category. The appointment orders to the provisionally selected candidates have been dispatched vide this office letter No.44400/TP2/2014, dated 05.12.2018."

3. In such view of the matter, the petitioner's representation was considered by the respondent and hence, this Writ Petition stands closed. No costs.
