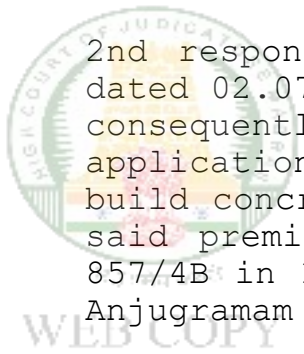

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a WRIT OF CERTIORARI/ MANDAMUS to call for the records relevant to the impugned order in D.Dis.C3/5141/2010 dated 19.11.2014 passed by the



2nd respondent and the consequential order in D.Dis.C3/32757/2011 dated 02.07.2015 passed by the 2nd respondent and quash the same and consequently directing the Respondents Nos.2,5 & 6 to process the application for building plan and to grant planning permission to build concrete building for the existing prayer hall as a church in said premises comprised 32 cents in Survey No.857, 857/4, 857/5, 857/4B in Door No.87-D, Kanimadam, Anjugramam Post, Azhagappapuram, Anjugramam Village, Agasteeswaram, Kanyakumari District.
