2.This writ petition has been filed for issuance of a writ of mandamus, directing the respondents 1 to 3 to remove the encroachment made by the 4th to 8th respondents herein on the pathway in Poramboke land in Survey No.6/1 and 11/6 situated in Ulaganeri Village, Madurai East Taluk, Madurai District based on the petitioner's representation dated 23.04.2018.
