PRAYER: Writ Petition under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records pertaining to the seniority list of Conductors, who are possessing degree issued by the 2nd respondent dated 21.12.2013 in Ref.No:11111/A2/Tha.Na.Aa.Po.Ka(Thili)/Nagar/2013 and consequential promotion orders issued by the 2nd respondent in his office proceedings No.11111/A2/Tha.Na.Aa.Po.Ka(Thili)/Nagar/2013 dated 24.06.2014 quash the same and consequently, directing the respondents to promote the petitioners to the post of Checking Inspector solely on the basis of seniority without reference to possessing of decree qualification.

**ORDER**

The grievances of the writ petitioners for grant of promotion to the post of Checking Inspector had already been redressed.

In this regard, the writ petitioners are at liberty to submit their representation setting out the facts and details and in the event of receiving any such representation, the respondents are directed to consider the same take a decision on merits and in accordance with law, as expeditiously as possible.
