2. Mr.J.Ashok, learned counsel for the petitioner would state that the petitioner has received all the papers and hence, he is not in a position to argue the matter. However, Mr.N.Dilip Kumar, learned Standing counsel for the respondents Bank would state that as the entire loan amount was paid, the Bank Account of the petitioner in Account Nos.15270005090022 and 152700480100413 were closed and the original documents have been returned to the petitioner.

In view of the submissions of the learned Standing counsel for the respondents, we are of the considered view that no further adjudication is necessary in the writ petition and hence, the writ petition is dismissed as infructuous. No costs. Consequently, the connected Miscellaneous Petition is closed.
