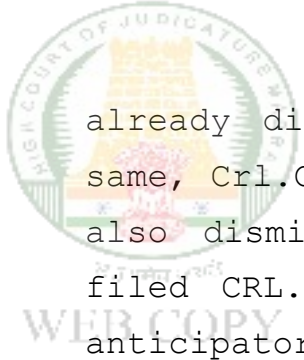

already directed the parties to take DNA Test. Challenging the same, Crl.O.P.No.6279 of 2017 was filed before this Court, which was also dismissed. Suppressing the said fact, the first respondent filed CRL.O.P.(MD)No.2780 of 2017 before this Court and obtained anticipatory bail. After that, DNA Test was conducted and a report in this regard has been filed.

4.The learned Additional Public Prosecutor submitted that this case has already been committed to the Mahila Court.

5.In view of the above, this petition stands closed.
