This Court is fully convinced with the reasons stated in the affidavit filed in support of the petition. However, the delay is inordinate and the respondent would be put to much inconvenience and hardship. Hence, this Court is inclined to allow this petition on terms.

2. Accordingly, this petition is allowed and the delay is condoned on condition that the petitioner pay a sum of Rs.2,000/- to the respondent counsel within a period of two weeks from the date of receipt of a copy of this order, failing which, this petition shall



stand dismissed automatically without any reference to this Court. Registry is directed to number the above, if the papers are otherwise in order and after showing the proof of payment.
