PRAYER IN CRP(MD) No.SR283 of 2018:-

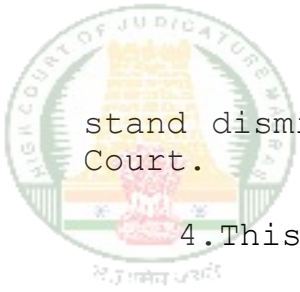
