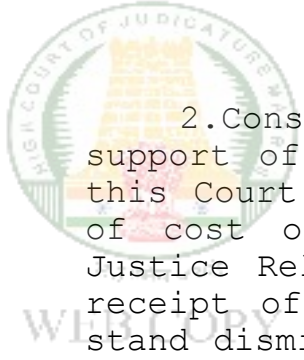
PRAYER IN SA(MD) No.SR10492 of 2018
