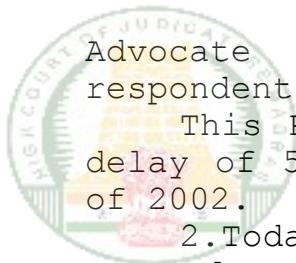
Prayer :- CMP(MD)No.12427 of 2018
