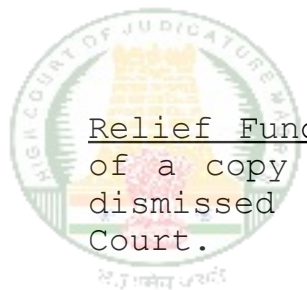
PRAYER IN CMA(MD) No.SR52579 of 2018
