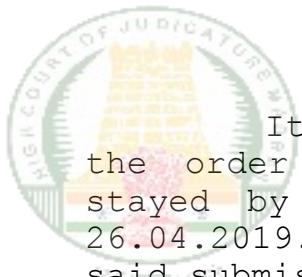
Prayer :-
