COMMON ORDER

These writ petitions have been filed seeking for a direction the respondents to frame guidelines for recruitment process with regard to the appointment of sub staff in Indian Bank and to appoint the petitioners based on their eligibility.

2.Though the prayers in these writ petitions are seeking Mandamus against the respondents, for framing appropriate rules, norms, etc., it is brought to the notice of this Court that in connection with the same, so far no representation has been submitted by the petitioners to the respondents.

3.Under such circumstances, the learned Counsel for the petitioners sought permission of this Court to withdraw these writ petitions with liberty to file a representation before the respondents and the same shall be directed to be considered on merits and he has also made an endorsement to that effect, which submissions is agreeable to the respective learned Counsel appearing



for the respondents.

4. In view of the above submission and the endorsement made by the learned Counsel for the petitioners, these writ petitions stand dismissed as withdrawn, granting liberty to the petitioners to file their respective representations to the respondents within a period of two weeks from the date of receipt of a copy of this order and on filing of such representations, the same shall be dealt with on merits and in accordance with law and necessary orders be passed, after affording opportunity of hearing to the petitioners, by the third respondent. No costs.
